Guidance for this examination

Examination structure

There are two sections to the examination paper:

- Section A Consists of six questions. Candidates should attempt to answer four questions. Total allocation of marks is 40 marks. Suggested time allocation is 30 minutes.
- Section B Consists of four questions. Candidates should attempt to answer two questions. Total allocation of marks is 60 marks. Suggested time allocation is 60 minutes.

Section A Candidates should attempt to answer four questions. Each question carries ten marks. Total: 40 marks.

- The Official Controls, as detailed in retained Regulation EU 2017/625, lay down minimum requirements in Chapter I, Annex II for the training of staff. Explain what these obligations include. (10 marks)
- 2. Annex II of retained Regulation EC 183/2005 on feed hygiene makes it a requirement that cross contamination from equipment must be avoided. Explain how this can be achieved.

3. Record keeping is critical for feed hygiene controls. When inspecting a feed manufacturer, explain what records you would expect to see on site.

- 4. Retained Regulations EC 852/2004 and EC 178/2002 define 'primary production' in relation to food.
 - (a) Explain what this definition includes and the types of premises to which it applies.

(b) What registration codes would you expect to typically be associated with primary production for feed?

5. With examples, explain what a business registered as an R12 is, and the type of feed likely to be placed on the market as a result of the activities of the Feed Business Operator.

6. In accordance with Article 15 of retained Regulation EU 767/2009, what are the general mandatory labelling requirements for a feed material or compound feed?

Section B Candidates should attempt to answer two questions. Each question carries 30 marks. Total: 60 marks.

7. Annex II of retained Regulation EC 183/2005 places a requirement on feed business operators to have written documented procedures based on HACCP. Compare and contrast the HACCP requirements to pre-requisite requirements for a raw pet food manufacturer.

8. Retained Regulation EU 2017/625, commonly known as the 'Official Control Regulations' (OCR), places a requirement on competent authorities for the verification of controls to be followed by industry.

Produce a report with regard to the requirements placed on the competent authority as a result of the OCR, including reference as to how the competent authority can ensure it meets the expected obligations of the law.

 As part of the obligations, for verification of compliance by industry, of retained Regulation EC 183/2005, you have been tasked with an inspection at a local family-owned feed mill producing complementary cattle feed.

Formal samples taken at the time of the inspection have identified processed animal proteins in the feed. As a result of this, explain in full what your next actions will be to ensure compliance with the rules.

10. With the departure from the EU, discuss the challenges being faced in the feed industry by the differing Feed Business Operators and by enforcement bodies who hold responsibility for feed.
